### GENERAL RULES

Booths are 10' X 10', and vendors are responsible for any and all booth structures, set-up, and furnishing, including but not limited to, signage, drapery, tents, and tables. Vendors may begin set-up at 8:00 AM and must open by 9:00 AM. Vendors must remain open throughout the entirety of the event, closing after 4:00 PM. **No vendors will be permitted to leave early under any circumstances.** Any violation of this early departure policy may result in the vendor being barred from this event in the future. Vendors are responsible for dismantling their booths and cleaning their area before departure. Vendors are solely responsible for the security of their goods. Additionally, vendors are solely responsible for any federal or state taxes associated with their participation in Tabouleh Fest. The Tabouleh Fest Committee reserves the right to expel any vendor who fails to abide by these rules or acts in violation of state or federal law during this event. **NO VENDOR MAY PARTICIPATE IN TABOULEH FEST WITHOUT SIGNING AND SUBMITTING THE ATTACHED LIABILITY RELEASE. NO REFUNDS DUE TO WEATHER.**
